# **Background information**

Raystede Centre for Animal Welfare, established in 1952, is a charity that aims to give animals a better life through rehoming, rehabilitation and sanctuary and give people the support and knowledge they need to treat animals with care and respect. We care for over 400 animals daily, including cats, horses, dogs, rabbits, hens and exotic birds. We help most animals find new homes and provide life-long sanctuary for some that cannot be rehomed. Our beautiful 43-acre site is open for visitors to get a unique glimpse into a working animal welfare centre.

Animals are at the heart of everything we do but we could not care for them without our expert and dedicated staff and volunteers. Surrounded by animals, lakes, trees and fields with a café, shops, parking and many other benefits, Raystede is an uplifting and rewarding workplace.

The Fundraising team generates income for Raystede through donations, legacies, events, and many other sources and activities. The Development Coordinator's role is crucial in developing our volunteering programme to support fundraising activities on and off-site. The coordinator supports volunteers and fundraisers to maximise opportunities in the community.

### Main Purpose of the role:

- Be the main point of contact for fundraising volunteers, ensuring records on our supporter and volunteer database are kept updated.
- Build volunteer fundraising support with excellent stewardship and support the development of our volunteer fundraising programme.
- Ensure our volunteers are trained and supported to carry out their roles.
- Coordinate activities on and off-site for the fundraising team and volunteers.
- Facilitate and build relationships in the community with individuals, small businesses and groups.

## Key Tasks

## Communication and supporter experience

- Manage volunteer recruitment for fundraising events and activities
- Manage diaries and Outlook calendars for fundraising to ensure volunteer support is planned
- Create a communication journey to thank and engage volunteers.
- Field all incoming calls and emails from volunteers
- Solicit feedback from volunteers and escalate if needed.
- Manage any volunteer issues for fundraising and escalate when appropriate.
- You will need to be able to answer a range of questions and ensure we comply with and keep up to date with current legislation.
- Create social media posts, recruitment materials, and campaigns for volunteers, working closely with the department head, HR and marketing team.
- Become the main point of contact at Raystede for anyone organising a fundraiser in the community on the charity's behalf.
- Plan and deliver recruitment campaigns.

# Admin and database

- Keep records up to date on our volunteer and supporter database
- Supply reports and insights into the fundraising volunteer programme
- Keep key point indicators updated monthly
- Responsible for leading and developing the management of our volunteer database and communication journey for fundraising.
- Capture and record data under GDPR and data protection guidelines.

# Volunteering

- Keep up to date with volunteering trends
- Develop volunteer roles and supporter groups to support our mission
- Ensure volunteers are trained and able to represent Raystede in the community
- Work closely with HR to develop our Volunteer Database
- Ensure our fundraising volunteers are recognised and celebrated.

# Activity coordination

- Coordinate diaries and book equipment.
- Meet volunteers to supply event materials, such as gazebos and literature.
- Manage equipment replacement when needed
- Work closely with fundraisers to ensure we maximise fundraising opportunities in the community.
- Liaise with the public to supply volunteers for fetes and fairs and other events.
- Occasionally, attend community events or drop off equipment when needed.
- Research new fundraising opportunities and activities for our fundraising volunteers to attend.

Other

- The post holder must keep up to date on Raystede's services and rehoming process and current animal welfare needs
- On occasion, supervise and/or support the public, businesses and event fundraisers to ensure they feel valued and supported.
- Manage risk assessments for the fundraising team and offer advice and support to ensure fundraising activities in the community are safe and legal.
- Prepare plans that link to the overall budgets and KPIs.
- Monitor KPIs and pledges.
- Contribute to budget setting and monitoring income.
- Build strong internal relationships to ensure effective communication and understanding between departments.

- b. Participate in supervision, appraisal, and learning and development and take personal responsibility for maintaining the knowledge and skills required for the role
