The Individual and Community Giving Manager will report to the Head of Fundraising, supporting the delivery of Raystede's five-year fundraising growth plan. The postholder will lead the strategic and operational delivery of Regular Giving, Community Fundraising, Events, Legacies and Database/Supporter Care. They will inspire and manage a high-performing team, grow sustainable income streams and ensure an excellent supporter experience across all touchpoints.

This role will ensure fundraising is fully integrated with animal welfare delivery, prevention and education, communications and visitor experience — creating a joined-up supporter experience that builds loyalty, value and long-term impact.

Key Responsibilities

1. Strategic Leadership

- Lead the implementation of the Public Fundraising Strategy, ensuring income growth and diversification across Regular Giving, Sponsorship, Friends of Raystede, Lottery, Appeals, Community, Events, In-memory, Legacy and Digital channels.
- Drive delivery against the five strategic objectives:
 - Diversify income
 - o Grow supporter base
 - Increase supporter value
 - Create compelling communications
 - Set the team up for success
- Align all public fundraising with Raystede's organisational Theory of Change (Prevention, Support and Care goals), ensuring fundraising stories and propositions clearly link to impact.
- Develop multi-year growth plans and annual budgets with realistic ROI targets and phased investment.
- Deputise for the Head of Fundraising when required.

2. Income Generation and Product development

- Lead income growth through sustainable, unrestricted fundraising streams.
- Develop and grow Regular Giving supported by reactivation and upgrade programmes.
- Build and embed the Lottery products to attract and retain lower-level or lapsed donors.
- Strengthen and scale Sponsorship and Friends programmes through improved stewardship and digital
 journeys.
- Champion testing and innovation across new channels, including digital acquisition, paid social and peer-to-peer.
- Implement the legacy strategy, increasing pledges and income over time.
- Ensure legacy prospects and pledgers are dealt with the utmost sensitivity.
- Oversee the continued building of the in-memory programme at Raystede.
- Oversee the development and delivery of an annual calendar of fundraising events.
- Support local fundraising groups, schools and businesses with bespoke resources.
- Grow community income through DIY fundraisers, challenge events and volunteer-led initiatives.

3. Supporter Development and Experience

- Oversee design and delivery of integrated supporter journeys across all income streams, ensuring a
 consistent, emotionally engaging experience online, on-site and through campaigns.
- Lead stewardship and retention strategies that increase Lifetime Value (LTV), cross-sell between products and strengthen relationships over time.
- Implement feedback loops, surveys and storytelling to demonstrate donor impact and reinforce lovalty.
- Embed a culture of supporter care across all teams, ensuring every interaction reflects Raystede's
 values and purpose.

4. Data, Insights and Performance

- Lead the development of a data-driven fundraising culture ensuring decisions, investments and campaigns are guided by insight and performance metrics.
- Oversee the CRM and to improve data capture, segmentation, automation and reporting.
- Introduce clear KPIs and dashboards to monitor income, acquisition, attrition, retention and ROI by product and channel.
- Drive continuous improvement through analysis of campaign results, benchmarking and insight sharing.
- Lead budgeting and forecasting for managed income streams.

5. Team Leadership and Capability Building

- Line manage and coach up to five direct reports, supporting a culture of collaboration, accountability and wellbeing.
- Build and lead a motivated, skilled and collaborative Fundraising Team with clear accountability and shared goals.
- Identify and address training needs, including digital fundraising, data literacy and stewardship excellence.
- Foster a culture of innovation, learning and confidence in "proudly asking" for support.
- Encourage cross-departmental working, ensuring all teams understand their role in income generation and supporter experience.
- Support recruitment and onboarding of new staff as the team grows.

 to embed fundraising messages and calls to action across all touchpoints.
- Partner with IT to deliver automation, improved online donation journeys and data integration.
- Collaborate with Finance to ensure accurate income forecasting, ROI modelling and reporting.
- Act as a visible ambassador for fundraising across the organisation, helping colleagues understand how every interaction supports sustainability.
- Collaborate with the Head of Marketing to ensure all content is accurate, current and on-brand.
- Collaborate with the Head of Fundraising to build a cohesive, high-performing team with shared goals.
- Ensure supporters can easily contact fundraising and receive excellent supporter care.
