- 1. All pitches cost £100 (both days), which is to be paid in advance and is non-refundable. Cheques should be made payable to "Raystede Centre for Animal Welfare". All proceeds go directly towards helping the animals.
- 2. Your space consists of 3m x 3m plot outside, uncovered and located on grass. Boundaries of sites will be marked and traders/exhibitors must ensure they allow for sufficient space for all stays or guy ropes required for any gazebos, tents or caravans to be erected on the space.
- 3. We would be very grateful for a prize to be donated to the Summer Fair Raffle.
- 4. Set up from 7.30am. All stall holders must be set up and cars must be off site by 9.30am.
- 5. Raystede accepts no responsibility for any vehicles or personal belongings left on site at any time.
- 6. All traders/exhibitors attending the Summer Fair must have their own insurance. Raystede excludes liability for any exhibit undertaken without insurance, this being at the exhibitor's own risk.
- 7. All stands must be opened and staffed throughout the time the Summer Fair is open to the public (10am 4pm). Stands must not be closed or dismantled before 4pm. Vehicles for the removal of stands will not be allowed to enter the site until this time, or when given permission. All stands must also be cleared of all materials, rubbish etc.
- 8. No exhibitor may sell any food stuffs or beverages on his/her stand unless permission has been obtained from the organiser prior to the Summer Fair. Exhibitors catering on their stands are reminded that they must conform to the requirements of the current Food Hygiene Regulations and produce copies of documentation to that effect with your booking form.
- 9. The allocation of sites will be entirely at the discretion of Raystede, although every endeavour will be made to meet any request made by the exhibitor regarding the position of his/her stand.
- 10. There are no services available.
